



## Theory of World Governance

A State's definition should be as a populated 'Piece of Land' or 'Group of Islands' with similar geographical conditions, wherein its spread should be limited to such distances, which can be travelled across its opposite borders 'Manually' or 'with help of Live stocks' or 'through Boats powered by Men', without use of any Machinery, within a period of Seven days. Two-way journey across opposite borders of a State should not require more than a Fortnight. A marginal approximation should be done to mark Boundaries/ Borders of a State, in such a way that naturally available milestones, such as- Rivers or Mountains are kept as definitive Borders. State's definition should include a clause, wherein it should share border with 'at least two other states', in the case where 'it is a land locked State' or with 'Ocean', in the case 'it is a coastal State or an Island'. A small parcel of 'Land of different geography' when it is completely surrounded by 'a State' should not be considered as separate State. A state in itself should be a place, which can sustain its population through available Vegetations & Natural resources or through Agriculture and Animal husbandry. An 'Uninhibited Parcel of Land' or a 'Land populated by Researchers' or 'a Land occupied only for drawing Natural resources', wherein food & supplies for livelihood are outsourced cannot be 'a State or Part of any other State'. Any Human activity other than Research, should be completely prohibited in such 'No Man's Lands'. A State in itself should be a Complete entity. A State itself should be considered as a Country or a Nation. Creation of larger Nations by joining Two or more States is always the root cause of uneven distribution of 'Revenues' or 'Political powers'. 'Political access' or 'Access to justice' for a common man remains a nightmare in larger states, due to layers of red tape.

Distance of Administrative centres (districts) within a State should kept in such a way that two-way journey to 'an Administrative centre' can be completed within One day by 'Manually' or 'with help of Live stocks' or 'through Boats powered by Men', without use of any Machinery.

Members of Council of Saints, Ruler, Ministers, Administrators, Judges, Teachers & Astrologers of a State should be pillars of State's functioning mechanism. Hence, they should always be appointed, from those born & brought up in the concerned State.

Selection or appointment for any occupation from A Saint to Ruler to an ordinary labourer should be done on the basis of evaluation of His/ Her 'Horoscope verified by His/ Her behavioural & Physical traits' & 'Expertise gained from Ancestral occupation'. 'Expertise gained from Ancestral occupation' should not be a criterion in selection of Saints, Ruler, Ministers, Administrators, Judges, Teachers & Researchers. Teachers should be given broader role in assessing their Pupil's traits. Verification of traits assessed by Teachers should be done through Examination of incumbents. Every single mismatch in data obtained from Horoscope, Teacher's assessment & Examinations must be tracked & appropriate judgement in this regard should be made by the Judiciary. The data & mechanism for selection of Study & Occupation of Persons should be transparent & accessible to all. Those found guilty for misuse of power, in conducting this kind of exercise should be given most severe Punishments.

Use of Machinery based or Motorised means of 'travel & transport' should be reduced to 40% of total 'travel & transport'. Remaining 60% 'travel & transport' should be managed with help of Domestic animals.

State, itself should refrain from indulging in any kind of Businesses. State's role with respect to Business should be limited to regulation & collection of Taxes. Role of 'Business people or Business organisations' must be restricted to their respective occupation. State must provide sufficient security to 'Business people or Business organisations' & at the same time 'Business people or Business organisations' should not be allowed to possess Arms or Armies, directly or indirectly. Pricing of Agricultural or Dairy products should be kept to such levels that those involved in Agriculture or Animal husbandry are able to sustain livelihood of their families through incomes generated from such occupations. Remunerations to Labourers should be kept to such levels that they are able to sustain livelihood of their families through incomes generated

from such occupations. Distribution of freebies by States or other organisations in any form should be avoided, except in the situations of Calamities or Draughts. Even such relief should be in a transparent manner & should be limited to 'actual utility of such relief' & 'period of such Situation'. Accounts of Governments & all Other organisations should be transparent & accessible to all.

Cross boarder 'Business people or Business organisations' should not be allowed to interfere in the matters of State's affairs or State's religious/ Cultural affairs. Cross boarder trade in a State should be driven by State's actual necessities. Any Product/ Service of international trade should be restricted or at least controlled through Duties or Taxes, if it impacts local Economy, even if the import is cost effective.

A 'State wise council of Saints' should be created. Approval from this council should be taken for Enactment or revision of Laws, specifically those related to;

1. Human behaviour with other Human beings
2. Human behaviour with Animals
3. Human behaviour with Trees
4. Nationals Laws, Strategies & Policies, along with Strategic decisions & decisions beyond Policies of the State.
5. Research Works (including Biotechnology).

Supervision of 'Implementation of these Laws' should be under the 'State wisecouncil of Saints'. The Council should be empowered to take punitive action against Ruler, Ministers, Administrators or Judged, not adhering to the norms set by the Council. Such actions should be limited to specific person or persons. Permission for En mass action against the whole system should not be given to the Council.

A 'Permanent Worldwide Council of Saints' should be created. Every State should be given equal participation in this Council. Foreign relations of all the States should be under observation of this Council. Nomination of members of 'Worldwide council of Saints' should be done by their respective 'State wise council of Saints'. Acceptance of proposed Names sent by 'State wise councils of Saints' for membership of 'Permanent Worldwide Council of Saints' should be decided by a 'Worldwide Committee of Saints', represented by 01 member from every State. States should provide birth charts & any other data related to proposed members of 'Permanent Worldwide Council of Saints', as required by the 'Worldwide Committee of Saints'. Membership of 'Permanent Worldwide Council of Saints' should be awarded after proper evaluation of proposed members.

Every State should contribute 1% of its nett annual revenue to this Council of Saints. In case, any State want to create its 'Arms & Army', such State should contribute, by providing complete technical know-how of technology used in Arms to Worldwide Council of Saints. At the same time such State should provide material & funds to the Council for creation & maintenance of equal quantity of such arms under the Council. That State should also provide funds & training for creation & maintenance of equal strength of Army under the Council. 'Worldwide Council of Saints' should maintain such 'arms & Army' under their control. 'Worldwide Council of Saints' should take action against those States or group of States, trying to alter boarders/ Boundaries of any State. States should provide sufficient place within their territories for Local & Worldwide councils of Saints. The Land provided so, should not be more than 1% of total area of respective State's territory. Share of 'Worldwide councils of Saints' in such land should not be more than 20% of land allocated for Councils. The Worldwide Council of Saints must provide relief, from their reserves, to People of those State's facing any Calamities or Draughts. All the Councils & Committees of Saints should have transparent accounting system, accessible to all.

Those Saints 'wish to' or 'have become part' of any 'Council of Saints' should be unmarried & they should not have/ had marital relations in any form. Any hereditary appointment of relatives of members of such Councils should be avoided. Representatives of 'Local State wise Council of Saints' must have another layer for observation of performance of 'Worldwide & Local Councils of Saints' & their members. Any Member of Councils, found to perform in a manner other than larger interest of Society as a whole, should be removed & punished. This exercise is necessary to have check on fake Saints.

If any person raise complaint against a Saint or Ruler or Minister or Administrator or Judge or Teacher or Researcher or Astrologer, for misuse of power in any manner, such complaint must be heard with highest priority. Full immunity to the complaining person should be given. Fast track enquiry should be done in such case & higher level of Punishment, when compared to ordinary Citizens, must be given to the Guilty.

A branch of Secret services under direct observation of Ruler of a State should be created for observing actions of Saints, Ministers, Administrators, Judges, Teachers, Researchers & Astrologers of the State & appropriate mechanism for taking necessary action against those found guilty must be designed. Punishment should be given to those found guilty. Trial & Judgment part for such cases should be transparent & under joint body of Judiciary & State's Council of Saints. If anybody is found guilty of corruption, along with punishment to him, his money & property (including those, kept at other places or indirectly owned by using any third party's name) should be permanently transferred to State treasury. If a Person, after conducting act of corruption,

leaves the State of his origin & try to take refuge in any other State. 'Permanent Worldwide Council of Saints' should be empowered to take action against such other States, trying to provide help to such corrupt Persons. The 'Permanent Worldwide Council of Saints' should hand over such corrupt Person to his Original State's authorities for Punishment. At the same time 'Permanent Worldwide Council of Saints' should enable transfer of such corruption money or material to original State's treasury, by using its authority.

Local laws should be formed in such a way that Harmony between various segments of the Society of a State is maintained. Anybody involved in creation of disturbances in society either by use of Media or Man power or Funds should be Punished.

Even in any kind of Emergency the structure of Government should not change. Neither the Ruler nor Council of Saints nor Judiciary nor Administration should be allowed to overtake the System. The Worldwide Council of Saints should draft their regulations, in such a way that they themselves cannot at 'any time' or 'in any situation' overrule sovereignty of a State, other than specified.

Inward migration of People of other states should be recorded. Inward migration should be permitted only to the extent to fulfil needs of the host State. As an exception, a temporary refugee inflow may be accepted, in order to help the people, in case of any calamity in their source state. Source State's consent should be taken for accepting back, return of such refugees, beforehand. Such emergency exceptions should be reversed by sending such refugees back to their original State, post end of such Calamity. Citizenship to inward migrants should be given, not before five years of their permanent stay. It should be ensured that inwardly Migrating people have respectfully accepted local culture & ethics, before they are awarded citizenship of the host State.

States should provide complete details of 'Researchers' & 'Specifics of their Research', to both 'State's council of Saints' & 'Worldwide council of Saints', along with their birth charts & other details as required by Councils. Any Research activity including its technical know-how, should be under monitoring of States & both the Councils. Any Research activity, if found inappropriate by State or Council/s of Saints, should be stopped & its related material should be destroyed. Researchers should be punished if they are found to be involved in any unethical acts. If Researcher's State do not take appropriate action, 'Worldwide council of Saints' should have complete authority & should take punitive or such other action against such Researchers, their Sponsors & the State. Cross boarder research activity should be under monitoring of host State along with Researcher's original State & both Councils. Any Research activity in 'No Man's land' or in 'the Space' should be under Supervision of 'Worldwide council of Saints' & all 'States'. If any objectional activity found or reported by anybody, the 'Worldwide council of Saints' should have complete authority to take punitive action such Researchers & their private as well as State Sponsors. The 'Worldwide council of Saints' should take strict action against all those involved in such 'unethical research work' or 'Conducts of other activities in the name of Research'.

Maximum Time limit should be fixed for 'completion' or 'disposal' of every part of Assignment or Task or Application or Complaint 'assigned to' or 'raised before' Member/s or staff of every Governing Authority including institutions like 'Worldwide Committee of Saints', 'Permanent Worldwide Council of Saints', 'State wisecouncil of Saints', Rulers, Ministers, Administrators, Judges, Teachers & Astrologers. A log book for recording times of actual fulfilment of every part of such Assignment or Task or Application or Complaint should be created. Time of actual fulfilment of every part of Assignment or Task or Application or Complaint should be compared with set benchmark. Concerned Authorities or officials found to be cause of unreasonable delay in completion of such task/s should be financially penalised & remarks should be noted in books related to their carrier. Those who are found to be cause of such delays for multiple times, should be removed permanently & replaced with other suitable persons.

Maximum limit of 'tenure of working life' & 'maximum age limit' should be fixed for members of all government institutions including 'Worldwide Committee of Saints', 'Permanent Worldwide Council of Saints', 'State wisecouncil of Saints', Rulers, Ministers, Administrators, Judges, Teachers, Astrologers & other government staff.

Promotion & increments in Salaries should be based on actual performance, as appearing in log books related to the carrier of members or staff of government organisations including those related to institutions like, 'Worldwide Committee of Saints', 'Permanent Worldwide Council of Saints', 'State wisecouncil of Saints', Rulers, Ministers, Administrators, Judges, Teachers, Astrologers. At least two separate chains of organisational structures of government departments should take note of such performances, individually. Decisions related to Promotion & increments should be based on compiled results of such separate organisational chains. Any variation in assessed performance from different sources should be noted. Sufficient enquiry in cases with such variations should be done. Loop holes should be fixed & those found behind misappropriations should be punished.

All the Committees & Councils, including those of Saints, should elect their respective Single Leader. The Leader should be enabler for working of such Councils & Committee. In case of equal division of votes in any decision making of a Council or Committee, Leader's decision should be the final & binding. A Leader's tenure should not be more than 08 years.

Manpower of Armed forces & Police department should be of indigenous origin of the concerned State. Control of Oceans under a coastal State should be limited to 50 nautical miles of oceanic surface from its Coast. In case, two or more States have some oceanic territory, common between them, such common area should be divided amongst them, based on ratio of their share in the Common Oceanic surface. Such narrow part of Ocean should be divided in three parts, such that; middle stretch of the Ocean remains under control of 'Permanent Worldwide Council of Saints'. Control of Other parts of all the Oceans should be under 'Permanent Worldwide Council of Saints'.

Distance of opposite side boarders of a State should not exceed 1200 kilometres, in case 'its geography is of Plains' or 'it is a group of Islands'. Distance of opposite side boarders of a State should not exceed 400 kilometres, in case its geography is of Mountains. Appropriate approximation should be done on the basis of nearby natural milestones.

Existing larger states should be divided into semi-autonomous administrative zones. Such administrative zones should have separate council of ministers, headed by a Prime minister. All such Prime ministers of administrative zones of a State should report to the Ruler.

'Permanent Worldwide Council of Saints', should have only one member from each State of the World. Recruitment of other staff should be done in such a way that all the States get proper representation. Representatives from all the States should have equal opportunity to speak on matters coming to the Council. But voting power for decision making should be limited to representatives from those States, whose permanent population is more than 10 Lakh (01 million). 'Permanent Worldwide Council of Saints' should have access to financials of all the States. 'Permanent Worldwide Council of Saints' should share 50% of annual fund, received from a State with respective 'State wisecouncil of Saints' of that State. 'Permanent Worldwide Council of Saints' should use its authority to re-instate original political conditions, if any section of that State's Governance has taken control over unintended part of State's system.

Maximum Time limit for 'completion' or 'disposal' of an Assignment or Task or Application of or Complaint 'assigned to' or 'raised before' Member/s or staff of any Governing Authority including institutions like 'Worldwide Committee of Saints', 'Permanent Worldwide Council of Saints', 'State wisecouncil of Saints', Rulers, Ministers, Administrators, Judges, Teachers & Astrologers should be 03 months. If any such task is not completed by respective Minister, Administrator, Judge, Teacher or Astrologer, such case should be transferred to another equivalent or higher authority. Such Authority should dispose the case within next 03 months.

'State wisecouncil of Saints' should have maximum five members. Out of these five members, one should be sent to represent the State in 'Permanent Worldwide Council of Saints'. Matters within the State should be looked after by remaining four members. One out of these four, should represent in 'Worldwide Committee of Saints'. 'State wisecouncil of Saints' should undertake its tasks with help of team of new generation of Saints, selected by the Council.

Appointment of every Government official should be under department of home affairs. Input data with respect to incumbent's traits, taken from Astrology department & Education department should be used along with requisite tests. Data from Tests, Astrology department & Education department should be given weightage in the ratio of 5:3:2 respectively. Compiled & raw data should be shared with Secret service (under direct control of Ruler) & 'State wisecouncil of Saints'. Both of these institutions should analyse the data. Discrepancies should be shared with Justice department for further action against those found guilty, if any. Final recruitment should be done, Post completion of this process.

Nomination of Saints for 'State wisecouncil of Saints' must include consent of Chief justice & Ruler. Appointment of Ruler, Ministers, Chief justice, Head of Armed forces & State Head of Police should include consent of 'State wisecouncil of Saints'. Maximum age limit for any one to remain part of Governance, should be 75 years. Maximum tenure of a person in Government service, including all kind of his/ her roles, should not exceed forty years. Minimum age for any government job should be 20 years. Ruler & 05 Members of 'State wisecouncil of Saints' should retire, after completion of maximum limit of their respective services of 20 years. Minimum age for becoming Ruler or Member of 'State wisecouncil of Saints' should be 40 years. Minimum age for Ministers & Chief justice should be 35 years. Minimum age for all district level administrative services, Astrologers & Teachers should be 30 years. Total number of Ministers of a State should not exceed 10. One astrologer should be included in the Ministry. There should not be any discrimination in selection or appointment or nomination for education or government service on the basis of Caste/ Religion/ Gender/ Wealth.

Education should be sponsored by the State & should be free for all.

The status quo on Citizenship/ Residence of every Human being residing in any respective part of this World, as on beginning of This New era (New Divine Day) Wednesday, 25<sup>th</sup> June, 2025 [Shukla Prathama (Amavasyant) Ashadha, 2126 Kali Samvat] at Morning 10:30 UTC, should be Protected.

It should be the duty of every Citizen/ Resident of every State to follow Rules/ Principles of his/ her respective State. Even if religion/ faith or caste or other such dividing factor related to a person are contrary to the Rules/ Principles of his/ her respective State, the Person should obey the Rules/ Principles of his/ her respective State.

Any Resident/ Citizen behaving contrary to this should be severely punished & made to obey the Rules/ Principles of his/ her respective State. Even then if, a Person does not obey, such Person should be thrown out of the State or removed permanently from the Society.

Worldwide Council of Saints should use its authority to force any State to revoke such Laws or Policies & their implementation, in case that State discriminates between its Citizens/ permanent Residents to the extent that such Laws or Policies are painful to some people or section/s of that State's Citizens/ permanent Residents.

A State should ensure that every piece of Land, 'measuring more than 04 square kilometres' or 'any common land of even smaller size, as per availability near given locality', should be considered as Forest. No private ownership, by a 'person' or 'group of persons' should be allowed for such Land/s or any other Land/s, with aggregate measurement/s of more than 04 square kilometres. No activity, other than grazing of Animals or Travel, should be allowed in Forest land/s. Night time entry to Forest land/s should be restricted. Hunting of wild animals should be completely banned, with exception for those people, who are traditionally forest dwelling people & do not have any relation with the Civil society, including that through agriculture, trade/ barter, animal husbandry or education. Plantation of trees of foreign origin should be banned. 'Cutting' or 'killing by removing bark or other methods', of 'Trees', with a general life cycle of more than 10 years, should be completely banned, unless specific Tree has dried naturally. Collection & use of naturally dried twigs should be allowed. Pruning of branches of Trees in agricultural land should be allowed. 'Slaughter' or 'killing by other means' of Animal/s or Bird/s like; Whale, Shark, Dolphin, Penguin, Elephant, Horse, Donkey, Cattle, Buffalo, Camel, Yak, Dog, Cat, Turtle, Ostrich, Vulture or 'that of other endangered Species in a State' should be completely banned. Any activity, other than Research, Travel & transport should be completely banned in those parts of Oceans, which are not under territory of any State. Use of motorised Boats/Ships for Fishing should be completely banned. Indigenous races of Crops & Cattle should replace Hybrid or that of foreign origin, since indigenous living things are better suitable for specific landscape & are robust against local diseases. Current generation of such Hybrid or foreign origin should be protected, until their natural death.

No Person should be allowed to possess dual or multiple Citizenship; hence Citizenship of every Person should be limited to one State only. A State giving Citizenship to an outsider should take consent from original State of applicant, before granting such Citizenship. Only persons with local Citizenship of a State should be allowed to own land or Property in that State.

Trial & Judgement for any Offence including Sexual abuse, by a person should be done in the State, where both the parties belong to. In the instance where, multiple States are involved, the State where Crime has taken place, should have right to run Trial & give Judgement. Place of Trial & Judgement for a Crime in 'No man's land' or common Oceans should be decided by 'Worldwide Council of Saints', wherein priority should be given to the State of affected person/s. Justice department should ascertain correctness of claims of Plaintiff/s before giving summon to Accused. Trial against a Ruler should be done after approval from respective State wise Council of Saints. Trial against a Minister, Judge, Chief of Armed forces, Chief of Police or those of ranks equal to or higher than District level Administrator should be done after approval from respective Ruler or State wise Council of Saints. Trial of a Member of 'State wise Council of Saints' should be done, post approval from 'Permanent Worldwide council of Saints'. Trial of a foreign Ruler, Minister, Judge, Chief of Armed forces, Chief of Police, District Administrator or any Officer of equal or higher rank than District Administration should be done post approval from 'Permanent Worldwide council of Saints'. It should be the duty of the relevant Court to take approval from respective authority. Application for such approval from the Court should reach relevant Authority within a period of 01 month, from the date of ascertaining correctness of Plaintiffs' claims. Ascertaining of correctness of Plaintiffs' claims should be completed within one month from date of Appeal for Justice. Respective Authority should be bound to deliver its decision with respect to approval of respective Court's such application, within a period of 02 months from date of receipt of application for approval.

Maximum 'Salary' or 'Remuneration by any other name' to any person should not be more than 100 times, of that of current minimum wages, paid to a Labourer in that State.

Total of direct or indirect Tax on any product, including that; levied by State or such other parallel authority, should not exceed '25% by proportion'. Tax collection should be on Output value & Input tax credit should be given to Tax payers. Farmers & Labourers should not be allowed to take input tax credit on their Products/ Services. Value added Tax system should be incorporated. Multiple types of Taxes should not be levied. Tax should be proportionately applicable to everyone, as per his/ her nett product. Higher Taxes may be

imposed on Imports, as per needs for such Products/ Services of importing State. Export of products from a State should be purely based on its surplus.

Governance, including Justice & Taxation should not be discriminative on the basis of Religion/ Caste/ Colour/ Race/ Sex of any Person.

A State should use its rights to make its Laws & Policies, Implement & Enforce such Laws & Policies, over its Land & Oceanic boundaries. For the Sake of legality its boundaries in Ocean should be considered as part of Land. State should use right to inspect, frisk, allow or disallow entry of a Person or Group of Persons or Ship/s or other means of Transport, entering in its Land or Oceanic boundaries. State should use its right to allow or disallow any kind of activities or businesses within its boundaries. No 'other State' or 'Citizens of other State' should be allowed to own part of land or Ocean within boundaries of a State, directly or indirectly.

State should use its rights to consider merged Land/s, property/s or wealth/s belonging to Person/s or Group/s of Persons, if such Land etc. are controlled directly or indirectly by Same Person/s or Group/s of Person/s through shell organisations or Agents. In case such Lands etc. are found to be more than 04 kilometres, State should use its right to take permanent control of such Land etc., without paying any considerations. Same logic should be applied on such Wealth or property/s, if they are found to be beyond pre-disclosed means of Income. Any private ownership over Waters/ part of Oceans should not be allowed.

State should use its right to manage its human populations, for keeping them to such levels as sustainable through State's resources. State should use its right to control growth of its human population, through enforcement of use of pre-fertilization contraceptives, beyond such numbers of babies per couple as thought to be fit for existing condition.

State should use its right to curb Polygamy & Polyandry or such other multiple marital relations in civil society, which disturb the 'right to marital life' of other populations.

State should use its right to channelise Food cycle. State should enforce policy of channelising Human waste in biological food cycles for use of Plants/ insects/ other animals. State should curb use of Latrines with pits, which disallow natural flow of Food cycle. Export of Human/ Animal waste should be curbed.

State should use its rights to manage contents & languages for Education, so as to keep them as indigenous as possible.

State should use its right to ban 'killing of specific race/s of Animals or Birds', in addition to those previously specified.

State should use its right to send back citizens of other states, post closure of their contracts for residence in the State.

Implementation of above laws or policies should not be discriminative on the basis of Religion/ Caste/ Colour/ Race/ Sex of any Person.

Before selection for Governance, concerned Person should have sufficient working experience. Ruler should have experience of minimum 05 years, as a Minister. A Minister should have minimum experience of 05 years, as Administrator/ Judge. An Administrator should have experience of 05 years in Government service. A Judge should have experience of 05 years, as an Advocate. Chief Justice/ Chief of Armed forces/ Chief of Police should have experience of 05 years, in their respective departments. Member of Council of Saints should have 10 years of working experience as a junior Saint in the Council of Saints.

Government should have access to 'classified data' & 'every transaction' of Banks. Validity of Currency of any state should be limited to boundaries of that State. There should not be any international Currency. All international trade should be paid through commodities, like metals/ minerals/ food products/ services etc. Prices of commodities should be purely based on demand & supply. State governments & Worldwide council of Saints should keep watch on prices. Possibility of any foul play or manipulation by Person/s or Organisation/s or State/s should be checked for & such unethical actors should be brought to justice for Punishment with seizure of such material.

All Persons & Vehicles should be inspected at exit points of State for international journey, for validation of purpose of journey & materials carried with them.

Any non-government organisation should not have more than 20 Partners. Every partner/ Owner of an Organisation should be bound to take complete risk & liability for actions of that organisation. There should not be any concept of 'Limited liability'. All kind of gambling, including Sale/ Purchase of Lotteries or Shares or Bonds of entities not directly related to such Buyer/ Seller, should be completely banned.

'Trade of Human beings' & 'Business of Sex' should be completely banned. Suppliers & buyers, in such cases should be severely punished. Sex workers should be rehabilitated.

Business of intoxicants including Alcohol should be completely banned. In cases of psychological issues, drugs as prescribed by Doctors should be administered to patients. Database of sale of such drugs should be maintained, for taking action on those mis utilising their role in supplies of such Drugs.

Use of Explosives should be completely banned, including their use by Army or for Mining. Mining should be completely a state subject. Role & remuneration of Labourers/ Agents should be limited to their work/

Supervision. Post mining, Minerals may be sold to Business people for further Processing or Trade. Ruler & State wise council of Saints should have complete access to 'classified data' & 'every transaction' for their proper analysis. Government official/s or other Person/s or Organisation/s involved in any manipulation or foul play should be punished & their properties should be Confiscated. Government office bearers should be permanently removed from their job, if they are found guilty.

State & its office bearers should not be involved in promotion or demotion of any Religion. State should promote celebration of Celestial activities. State's offices should be open on all days of year. Individual officials should be allowed to take leaves, as per their needs. Number of leaves allowed for an Official should not be more than 65 days, in a Solar year. Government Office bearers should be allowed to follow their respective faiths, but only as their private affair. 20<sup>th</sup> March should be common beginning day of accounting/ financial year for States & Businesses.

To begin the process 'State wise council of Saints' may select the Ruler & Ministers. Members of 'State wise council of Saints' may be nominated by wider diaspora of Saints of respective State. For the initial round, criteria of age & experience may be overlooked. Other existing state office bearers may continue their duties.

Example; India as a model State

To begin with Four Shankaracharya's; Sri Nischalananda Saraswati ji (Puri), Sri Bharati Teertha Mahaswami ji (Sringeri), Sri Sadananda Saraswati ji (Dwarka) & Sri Avimuktेश्वarananda Saraswati ji (Joshimath) do accept role of members of 1<sup>st</sup> 'State wise council of Saints'. Another member be elected by heads of 13 Akharas of Saints.

State of India be divided into four administrative zones;

1. North- Uttaranchal, Uttar Pradesh, Delhi, Chhattisgarh & Madhya Pradesh
2. West- Jammu & Kashmir, Ladakh, Himachal Pradesh, Punjab, Haryana, Chandigarh, Rajasthan, Gujrat, Maharashtra, Dadar & Nagar haveli, Daman - Div & nearby oceanic territories
3. South- Telangana, Andhra Pradesh, Karnataka, Kerala, Tamil Nadu, Goa, Pondicherry & nearby oceanic territories
4. East- Rest of India

All above four zones should have their respective council of ten Administrators, headed by a prime minister. All four prime ministers should report to the Ruler of India. There should be 10 Central Ministers, Reporting directly to the Ruler. Each of Administrators from all four administrative zones should also report their data to the Respective Central Minister. Central Ministers are decision makers, where as representatives of administrative zones should perform roles of implementation.

To begin the process 'State wise council of Saints' should nominate the Ruler, all Central Ministers, four Prime ministers & all forty Administrators. The 5<sup>th</sup> Member of 'State wise council of Saints', elected by 13 Akharas to represent India in 'Worldwide Council of Saints'.
